



FREE SMARTPHONE PROMOTION

PROMOTION RULES:

1. By entering the promotion entrants agree to abide by the rules and conditions of the promotion.
2. This promotion is open to legal residents of the Republic of South Africa, who are customers and punting in the Republic of South Africa", who are 18 years or older, except the employees, directors, members, partners, agents or consultants of Phumelela Gaming and Leisure Limited (trading as TAB), the promoters and their respective advertising and promotional agencies, media and PR agencies, as well as the immediate family members, consultants, directors and associates of such organizations and persons, including its holding company.
3. The promotion will commence on 27 September 2018 and will run indefinitely or while stocks last.
4. Smartphone stocks are limited to the first 1300 customers.
5. How to enter:
 - 5.1 For a new account holder to receive a free Vodacom Kicka smartphone, you must:
 - 5.1.1 Register a new TAB account by going to cell.tabaccounts.co.za and following the prompts.
 - 5.1.2 Supply FICA documentation as required to activate the account.
 - 5.1.3 Deposit a minimum of R399 into the new TAB account within 72 hours
 - 5.2 Existing account holders cannot qualify for the free smartphone, however, they can receive R100 free airtime by:
 - 5.2.1 Depositing a minimum of R399 into your TAB account as a single deposit between 27 September 2018 and midnight on 30 September 2018.



- 5.2.2 Send the word "Airtime" and your TAB account number to 071 388 1249 via WhatsApp
- 5.2.3 If you qualify we will send R100 airtime to the cell number we received the WhatsApp message from.
6. You will be contacted by a TAB agent within 48 hours of qualifying for the free smartphone to confirm eligibility and delivery address.
7. The phone bundle will be couriered directly to you and the courier will contact you to arrange delivery time and place.
8. Deliveries will only be carried out to locations within the borders of the Republic of South Africa.
9. Should you not be available to take delivery at the agreed upon time and place, you may be required to pay for any re-delivery charges at the discretion on the promoters. Alternatively, you will need to collect the parcel from a location convenient for the promoters.
10. The Smartphone package will include:
 - 6.1 1 x welcome pamphlet
 - 6.2 1 x new Vodacom Kicka Smartphone (variable kicka models)
 - 6.3 1 x SIM card
 - 6.4 2 x betting explanation cards
11. In the event that you do not or can not supply any proof of address, the free SIM card and airtime will not be included in your parcel.
12. The device presented to the winner may differ from the image used in advertising or promotional materials and the Promoters reserves the right to substitute the prize with one of a comparable value.



13. Should a person who is either under 18 years of age or not a legal resident of the Republic of South Africa be eligible, they will be disqualified from receiving the promotional items.
14. The Promoters will make all reasonable attempts to contact the winner or winners but if any winner cannot be contacted within 48 (forty-eight) hours from the date of qualifying to receive the promotional items, they will forfeit the right to the items and these will be reallocated. It is the entrants' responsibility to provide the correct contact details.
15. The Promoters will do the delivery of items within 14 days.
16. The Promoters reserve the right to cancel the promotion for any reason whatsoever.
17. In the event that the organisers run out of stock of smartphone devices, the remaining stock will be distributed on a first-come, first-served basis and no promotional items will be provided to those who qualify after the stock has run out.
